Your team has been accepted to play in the 34<sup>th</sup> Annual U11-U19 USYSNV Silver State Invitational Soccer Tournament on January 26-27, 2008, U11-U14 & February 23-24, 2008, U15-U19. We look forward to seeing you at registration and at all the festivities that have been planned in your behalf to make this a Tournament to Remember!

All matches will be played at the Las Vegas Bettye Wilson Soccer Complex, 7353 Eugene, LV, NV 89128 (next to Cimarron Memorial High School, 2301 North Tenaya Way, LV, NV 89128) on (10) lit natural grass fields and the Kellogg/Zaher Soccer Complex 7701 Washington, LV, NV 89128 on 7 lit synthetic and 4 lit natural grass fields, unless otherwise posted. Both complexes are within 1.5 miles of each other. Host of the 2007 Far West Regional Tournament.

Some players use "Turf Shoes" and wear "Sliders" when playing on the synthetic fields.

There will be all types of concessions, including drinks, food, T-shirts, Tournament pins and action photos taken at all matches & great bargains to purchase.

This **letter** gives the information about the tournament, while the **T-shirt pre-order** form, is also included. You will need to mail the **T-shirt pre-order** form and **Program Ad order** form (can be found on the Web page if you are interested in advertising in this years tournament program) to the above address by Tuesday, January 15, 2008, U11-U14 & Monday, February 11, 2008, U15-U19. In addition, the **Team Final Roster** form can be found on the Web page. You will need to bring the **Team Final Roster** form to the tournament check-in. Roster must be LEGIBLE, ACCURATE and COMPLETE.

Your **match schedule**, Tournament Rules, Maps of the Complexes and surrounding areas and all current tournament news before and during the tournament will be posted on **USYSNV.Net** web page, **TOURNAMENTS, SILVER STATE INVITATIONAL**.

If you didn't include your email address, cell phone # or the address you will be staying in Las Vegas on your application, make sure you include it on your Check-in paperwork. The tournament rules, Schedules and maps of the Bettye Wilson and the Kellogg/Zaher Soccer Complexes will be in the program which you will receive at check-in in your coach's packet. All teams are guaranteed at least (3) matches (unless out of the tournament committees control).

There will be a **mandatory** team check-in on Friday, January 25, 2008, U11-U14 & Friday, February 22, 2008, U15-U19 between 6:00 - 9:00 PM, Please check our web site for check-in location. Light refreshments will be served.

Due to the number of teams checking in and out of consideration to the other coaches/managers, please refrain from bringing children to the check-in.

All teams will be required to provide the following at team registration:

- \* Travel Papers (all teams other than Nevada).
- \* A signed Medical Release for each player.
- \* Signed & Laminated 2007/2008 League player and coach passes for all tournament participants.
- \* A copy of the Birth Certificate for every player NOT registered in USYSNV.
- \* A properly completed Guest Player Form for every player not on your registered league team (maximum of [5] guest players).
- \*The Official Final Team Roster to be compared with your player/coach passes.
